#### 2019 Pastor's Annual Report- The Rev. Dr. Kevin Yoho

"When the men came to Jesus, they said, "John the Baptist sent us to you to ask, 'Are you the one who is to come, or should we expect someone else?" At that very time, Jesus cured many who had diseases, sicknesses, and evil spirits, and gave sight to many who were blind. So he replied to the messengers, "Go back and report to John *what you have seen and heard*: The blind receive sight, the lame walk, those who have leprosy are cleansed, the deaf hear, the dead are raised, and the good news is proclaimed to the poor. Blessed is anyone who does not stumble on account of me" (Luke 7:18-23, NIV).

Hello Cold Spring Church friends,

#### What have you seen, heard, and experienced?

I am grateful and energized to serve as the Transformation Pastor (interim) at Cold Spring Presbyterian Church. Thank you for the privilege. I thank God for increasing our spiritual energy, engagement, and participation. For example, individuals are volunteering to serve in our session, deacons, and other teams. We are blessed to have received seven new members in 2018! Look around to see the many ways our congregation generously shares their Time, Energy, and Attention (TEA). This not only *supports* our ministry, but represents an investment to *expand* our ministry's positive effects in our community! C.S. Lewis famously observed that *God is on the move!* We are invited to open our eyes and see all that God is doing in our midst.

We all need encouragement from time to time to see what in right in front of us. In the text above from Luke 7, even John the Baptist wanted documentation that gave evidence that Jesus was the promised Messiah, the Christ who takes away the sins of the world. He sent his followers to ask Jesus directly: "Are you the One?!" Jesus simply instructed them to tell John what "you have seen and heard." Re-read the list, above. How excited John's questioning followers must have felt after reflecting on their list! Each report of healing, hope, inclusion, forgiveness, and freedom represented dozens of personal stories of changed lives. This Annual Report only hints at what many individuals have experienced at Cold Spring Church.

Our energizing worship of Jesus Christ has lifted the spirits of people of all ages in music and song by our singing team. Young and old alike have heard God's word preached as we have been inspired to live and love others during the week; to look more like Jesus. We welcomed guests and many returning visitors almost every week. We honored and celebrated the lives of those who have passed, and served many more though our cemetery ministry. We joined people in marriage, and held our second Ash Wednesday service in Price Hall and Easter sunrise service at Cape May Point, and welcomed even more people to our Easter and Christmas Eve services. More people are getting involved and sharing the blessings.

Our *Focus Your Vision* event in June rallied us to be open to what God is doing as we continue to focus, refine, and invest in our vision. Our *Mission Study Team* will be presenting its findings this Spring which will help to make better decisions about the focus of our ministry, which we refer to as our *mission*. Our *mission* is what we have been called to accomplish together as a community of faith, a church of Jesus Christ. More answers to prayers and expressions of gratitude have been heard. Testimonies of new found hope have been shared.

Many who were sick, God healed. Those who sought resources to live a better life have found them (such as our highly attended Opioid Overdose Prevention Training held in Price Hall). People who felt stuck have found freedom. Those who were burdened found relief and were cared for. Those who were shut-in were visited. Those who felt like a stranger, now feel welcomed and included as our friends. Bible studies, dinners, events, Session, Deacon, and Presbyterian Women's activities, have together offered our community important ways to feel connected to one another. Local ministries and national tragedies have been funded and prayed for. Look around and you will see a new sign, updated lighting, expanded kitchen, needed repairs have been completed, and other improvements that point to effective and loving leadership offered by our officers and staff. When we have our eyes opened, we see that *God is on the move* right here in greater Cape May, and *you*, all of us, are essential parts of God's movement of the Holy Spirit!

#### **Our Bold Transformation Process Continues**

When Presbyterian congregations seek pastoral leadership, most churches call a pastor after a 12 to 24-month search. For example, until 2016, Cold Spring Presbyterian Church has been served by full-time pastors. When a pastor concludes their time of service, the session, in consultation with the presbytery, approves the services of a full-time interim pastor. The interim essentially helps to maintain the current level of ministry until the congregation is ready to call a new pastor. Often during an interim period, the congregational energy and membership decreases as the congregation begins a search for a pastor. Eventually, a new



pastor is elected by the congregation who begins their work until such time when the pastor leaves. Then the cycle repeats.

In 2016, when the full-time pastor concluded his years of service, the session and presbytery's Committee on Ministry (COM) approved a part-time interim. The session and COM prayed and reflected upon the results from many short-term pastorates/interim cycles which produced less spiritual energy and growth than expected.

In 2016, the session determined that it wanted to reverse these trends associated with the traditional pastoral calling process and accepted a bold challenge proposed by the COM and presbytery. A transformation specialist pastor would be sought to lead the congregation on a transformational journey to stimulate spiritual energy and lead to improved congregational health and growth. The job of a transformation pastor is to help lead the session to reconnect the spiritual assets of the church with the needs of the community. The process includes proclamation of the Good News about Jesus, Biblical and reformed emphasis, developing spiritual leadership, introducing best practice principles of congregational growth, and outward-directed ministries. Meeting the ongoing needs of the congregation is the priority of the session and presbytery. In the future, a change back to a non-specialist pastor, or a traditional interim/pastor model, would be considered by the session and COM, with the approval of the presbytery.

In September 2016 the session invited me to serve as the transformation pastor instead of using the alternative traditional interim, generalist, and pastor as in earlier years. We do not require a pastor nominating committee, and there is no need to search for a pastor. Instead, this congregation is led on its transformation journey by the transformation pastor. The COM works with the session to equip the entire congregation to focus on improving its health and growth. The prayers, hopes, and plan is that by stepping out of the traditional interim/called pastor cycle into a transformational journey, the congregation's spiritual energy and community ministry will increase each year. In September 2018, the session and presbytery approved another year of my service as the transformation pastor that can be renewed annually for up to three years. I am delighted to serve in this capacity.

While other Presbyterian congregations are effectively served by the traditional models, many others experience decline and grasp for survival. But Cold Spring Presbyterian Church is different! Our congregation is experiencing energy and growth because it is on a transformation journey. We are moving forward to vitally connect Christ's Good News, and Biblically-based spiritual and other resources to the community at large. God has blessed us with a wonderful history, rich spiritual roots, and an amazing congregation, a beautiful campus including our red brick church, cemetery, Price Hall, other buildings, and a great staff! The transformation journey invites all of us, in our unique ways, to participate in learning, improving, and trying new things, together.

"Now to him who is able to do immeasurably more than all we ask or imagine, according to his power that is at work within us, to him be glory in the church and in Christ Jesus throughout all generations, for ever and ever! Amen" (Ephesians 3:20).

#### **Worship and Music Team Report**

The Worship and Music Team coordinates the order, content and music of our worship services in cooperation with the pastor and organist/music director. Team members are Pastor Kevin Yoho, Jayne McDonough (organist/music director), Lenore Bowne, Rob Riehl and Marty Bowne (chair).

Our worship services are based on the Sunday and religious holiday portions of the Lectionary, which is a method that, if read daily over a period of three years, covers much of the Bible. In general, Pastor Kevin prepares his messages to align with the Lectionary readings. Hymns sung by the congregation are selected by the pastor, in consultation with the organist/music director, to complement the Lectionary and pulpit message themes.

During 2018 we reintroduced a congregational greeting as part of our worship service. At the discretion of the pastor, this greeting is either a warm "hello; how are you?" or "passing the peace", generally on communion Sundays. We also have expanded the group of communion servers to include all members of session, as well as other members of the church who wish to participate in this capacity.

Our music program also was enhanced during 2018. Our singing team has grown to six members who, except for the summer months, practice each Sunday morning and generally participate in the worship service on the second and fourth Sundays of the month (weekly during the Easter and Christmas seasons). New members of the team are always welcome. If you would like to join, please contact Jayne McDonough. We also have expanded the hymn selection for the congregation beyond the traditional blue and red hymnals. On many Sundays there are bulletin inserts containing selections from *Glory to God*, the most recent Presbyterian hymnal, or themed hymns that reflect the pastor's message.

The Worship and Music Team, in partnership with the Congregation and Community Life Team, initiated a series of social events in 2018. These included Sunday brunches at the Back Bay Bistro in Villas, a Harvest Festival pot luck dinner in Price Hall, and a recent pot luck luncheon honoring the seven new members who joined our church during 2018. These social events were well received and will continue in 2019.

When we think about worshipping at Cold Spring Presbyterian Church, our primary focus probably is on the pastor leading us from the pulpit and the beautiful organ music created by our organist/music director. And that is a correct primary focus. However, there are so many other functions and people involved in making our worship services so inspiring and effective. In addition to Pastor Kevin and Jayne McDonough, I want to take this opportunity to recognize and thank all those who help to create a successful worship experience by participating in the following activities: creating the bulletin and inserts; making sure we have flowers; being liturgists/worship leaders, greeters, and ushers; being members of the singing team or singing solos or duets; teaching Sunday School to the children; preparing and serving communion; making us aware of the health status of members and others in need of prayer, counting weekly offerings and making bank deposits. It's a very long list and, if I've omitted anyone who has a role in our communal worship, I apologize.

For those who may want to get more involved in our worship and music program, I invite you to join our team (please contact me). I'm sure you will make a valuable contribution.

Price Hall lighting has been updated. The lights were installed by Dave our Sexton. Five additional hanging lights will be installed soon. Also, window valances and 2x2 square commercial carpet tiles will be added to assist with sound and acoustics.
